QUALIFYING CRITERIA

Name of the work: "AMC for Mechanical Maintenance of Ash Handling Plant including Ash Water Recovery System, HCSD System and Mill Reject Handling System" (02 Parts)

Bidders having the following criteria shall only be considered to be qualified in the Techno-commercial Bid:

1. Party must have executed Annual Maintenance Contract for the Mechanical Equipments of Ash Handling Plant and HCSD System (with GEHO Pumps or Equivalent) for Power Plant of capacity greater than or equal to 600MW.

And

2. Must have worked in any Govt. / Public Sector Utility / Private Sector having unit capacity of 600 MW and above.

And

3. Safety Requirement- Bidder Loss Time Hours must have been less than 200 Hrs in last 3 years. (Contractor's Self Certification)

And

- 4. Must have successfully completed similar work* during last Five years ending the last day of the month previous to the one in which tenders are invited.
 - a) At least single annual contract of value not less than Rs. 2.5 Crore for Similar work.

Or

b) At least of two annual contracts of value not less than Rs. 1.5 Crore each for Similar work

Or

c) At least of three annual contracts of value not less than Rs. 1 Crore each for Similar work

And

5. Average Annual financial turnover during last three financial years (17-18, 18-19 & 19-20) should be Rs.04 (Four) Crore or more. Audited Balance Sheet and profit & Loss A/C must be submitted along with the Techno-commercial Bid. In

case the account is not audited a certificate from a chartered accountant should be produced towards turnover.

And

- 6. The bidder must not have been blacklisted or debarred to participate in tendering of similar jobs earlier by any Govt./Public Sector Utility / Private Sector
- 7. The bidder must have own Provident Fund Code, Goods and Service Tax (GST) Code and Income Tax PAN. Photocopies of these documents must be submitted along with Techno-commercial Bid.
 - *Similar Work It implies the Annual Maintenance Contract of Ash Handling Plant and HCSD (High Concentration Slurry Disposable System) system

Acceptance of Reverse Auction: Bidders are to give their acceptance for participating in e-Reverse Auction through M/s.MSTC in addition to the submission of manual Price Bids. E-RA will be held after opening of manual price bids and the lowest among both manual bids and e-RA will be considered further for evaluation.

The detailed terms and conditions of the e-Reverse Auction is mentioned in the tender document as "RULES AND REGULATIONS OF THE E-REVERSE AUCTION".

NB: The transaction fee for e-RA will be @0.03% of starting Price maximum up to Rs.10,000/- + Taxes as applicable, payable to M/s.MSTC.

Note:

- For all qualification criteria all supporting documents to be provided.
- Owner reserves the right to obtain necessary documents and also to assess the qualification of the Bidder, subsequent to submission of bid, as deemed necessary by Owner to establish bidder's qualification.
- The bidders who are found qualified in above will be invited for the opening of the price bids.
- Tenders submitted without the above techno-commercial requirements shall be liable for rejection.
