Bidder Qualification Requirements

1. Bidder must have executed Annual Overhauling Contract for Boiler Pressure Parts and Fuel Firing System Equipments for Thermal Power Plant having Unit size 660 MW or above.

And

2. Experience of having successfully completed similar works(as mentioned below in Point a, b and c) during last 5 years ending last day of month previous to the one in which applications are invited should be either of the following:-
 - a) Three similar completed works costing not less than Rs. 55 Lakh each.

[-One out of three similar works must include Overhauling of Boiler Pressure Parts and Fuel Firing System Equipments]

[-Second and Third similar work must include Overhauling of Boiler Pressure Parts, may or may not include Fuel Firing System Equipments]

OR

- b) Two similar completed works costing not less than Rs. 70 Lakh each.

[-One out of the two similar work must include Overhauling of Boiler Pressure Parts, may or may not include Fuel Firing System Equipments]

-Second similar work must include Overhauling of Boiler Pressure Parts and Fuel Firing System Equipments]

OR

- c) One similar completed work costing not less than Rs. 1.1 Crore each.

[One similar work must includes Overhauling of Boiler Pressure Parts and Fuel Firing System Equipments]

Copies of work order to be submitted as supporting documentary evidence along with the technical bid.

And

3. Average annual financial turnover during last three years (i.e. 2017-18, 2018-19 and 2019-20) should be Rs. 2 Crore or more. Audited Balance Sheet and profit & Loss A/C must be submitted along with the Techno-commercial Bid. In case the account is not audited, a certificate from a chartered accountant should be produced towards turnover.

And

4. The bidder must not have been blacklisted or debarred to participate in tendering of similar jobs earlier by any Govt./Public Sector Utility / IPP/ CPP. (Self certification required)

And

5. Photocopies of Provident Fund Registration certificate, ESI Registration certificate, Income Tax PAN and GST certificate. Photocopies of these documents must be submitted along with Techno-commercial Bid.

And

6. The Bidder must be an approved special class (U/R 392 of IBR) Boiler Repairer in Odisha state at the time of submission of Bid. Copy of Boiler Repairer certificate issued by Director of Factory & Boiler, Bhubaneswar, Odisha shall be submitted along with technical bid.

Note:

- **For all qualification criteria all supporting documents to be provided.**
- **Owner reserves the right to obtain necessary documents and also to assess the qualification of the Bidder, subsequent to submission of bid, as deemed necessary by Owner to establish bidder's qualification.**
- **The bidders who are found qualified in above will be invited for the opening of the price bids.**
- Tenders submitted without the above techno-commercial requirements shall be liable for rejection.
